

**AMENDMENT NO. 1
TO THE PROFESSIONAL SERVICE AGREEMENT BY AND BETWEEN
THE SIERRA VALLEY GROUNDWATER MANAGEMENT DISTRICT AND
STETSON ENGINEERS, INC. FOR STATE OF CALIFORNIA DEPARTMENT OF
WATER RESOURCES AND SIERRA VALLEY GROUNDWATER MANAGEMENT
DISTRICT AGREEMENT NUMBER 4600015875 SUSTAINABLE GROUNDWATER
MANAGEMENT ACT (SGMA) IMPLEMENTATION GRANT**

WHEREAS, an agreement was entered into the 15th day of April, 2024, (“Agreement”) by and between the SIERRA VALLEY GROUNDWATER MANAGEMENT DISTRICT (“DISTRICT”), and STETSON ENGINEERS, INC. (“CONTRACTOR”), to provide sustainable groundwater services; and

WHEREAS, the Agreement provides for amendments pursuant to Section 7.2, Amendments, where the parties may amend the Agreement only by a writing signed by all the parties; and

WHEREAS, the parties wish to amend the following parts of the Agreement:

1. Budget and Billing Rate Schedules (Exhibit B); and

WHEREAS, the Agreement provides for amendments.

NOW, THEREFORE, the parties agree to the following:

1. Amend Section 2.10 Maximum Cost to District, in its entirety with the following:

Notwithstanding any other provision of this Agreement, in no event shall the cost to District for the services to be provided hereunder exceed the maximum sum of one-million one-hundred and forty-nine thousand dollars (\$1,149,000.00).

2. Amend Budget and Billing Rate Schedules (Exhibit B), in its entirety with the following:

The scope of services components and categories in **EXHIBIT A** will be completed for a cost **not to exceed \$1,149,000** on a time and materials basis according to the Contractor standard billing rates, attached, and budget line items shown in the below table, by component and category, subject to the Grant Agreement between the State of California DWR and Sierra Valley Groundwater Management District (Agreement Number 4600015875) Sustainable Groundwater Management Act (SGMA) Implementation Grant (Attachment 1) Exhibit B (Budget) for Contractor (Stetson Team):
